

# Certificate of Exemption – AGAR 2020/21 Part 2

There are certain circumstances in which an authority will be **unable to certify itself as exempt**, so that a limited assurance review will still be required. - The court has not declared an item of account unlawful after a person made an appeal under section 28(3) of the Act.

If you are able to confirm that the above statements apply and that the authority neither received gross income, nor incurred gross expenditure, exceeding £25,000, then the Certificate of Exemption can be signed and a copy submitted to the external auditor **either** by email **or** by post (not both).


