c) Invitation to make representations on the Draft Bassetlaw Local Plan Resolved unanimously that a response is sent highlighting concerns about:

- Proposed new housing for Dunham on Trent during the plan period of 39 houses, which is unrealistic with the restrictions already place on the area such as: public transport – this is only operated on a dial a ride basis, school – is already full and is oversubscribed, flood zone – much of the Eastern side of the village is within the flood zone and therfore not suitable for residential development, doctors – the doctors is in Tuxford or Sutton on Trent, there is no capacity at Sutton onTrent for new patients
- Development plans for former Cottam Power Station site is questioned as there is no classified highway network anywhere near the site. Approximately half the traffic would need to pass the primary school at Dunham, which already experiences excessive speeds and inappropriate driving, this will be compounded by the addition of such a large volume of additional traffic
- Development plans for the High Marnham site, will worsen the existing issues with excessive HGVs on rural unclassified roads. It is hoped that the Parishes to the south of the site in the Newark & Sherwood Cllr Council (NSDC) area have been consulted as well as NSDC
