The Road from Fledborough to Ragnall needs making safe as it is sinking into the dyke. - The Clerk would enquire of Highways, Nottinghamshire County Council again, once Cllr. Oakden had supplied photographic evidence.

Rospa – The clerk would investigate the situation.

Lengthsman – the Council accepted the offer of a copy of the Rights of Way Survey being undertaken. Faults reported would be forwarded to Nottingham County Council.

County Footpaths – The styles are becoming dangerous and causing a safety issue the clerk would request kissgates to be installed as a replacement.

No Parking signs – properties close to Darlton play area would like no parking signs to prevent the public parking on their land. The Council would offer a contribution towards the cost.

New fencing had been supplied and fitted by Mr David Cobb, the Council would like to thank Mr Cobb on behalf of the residents for his generous contribution to the play area.

Comments:

Dunham on Trent Parish Council support planning in this area however this application is not in keeping with other detached properties in the area. Access to the garages would be improbable given the dimensions and turning arc. Although privacy issues seem to have been addressed with privacy glass there is no mention of privacy glass on the other side of the property which would be the main living area.

The Council view this application as an ovrdevelopment for the size of plot of land, one cottage would be more suited.
